#### **HOW DOES THE ENGAGEMENT WORK?**

As a Consulting engagement, we can adjust it to meet your exact requirements but, in general, our Cloud Migration Services work as follows:

- Planning Workshop, facilitated by an expert Azure Consultant, to establish key priorities and principles for the migration, such as how workloads are to be defined and ordered.
- Our Consultants create run-books for each tranche of workloads. These contain step-by-step for server or service pre-, during and post-migration.
- We use Azure Migrate to analyse the infrastructure and determine the specification of target virtual machines, etc. Sometimes it's already in place from an early engagement –other times we need to install as part of this engagement.
- Depending on the specifics of the workloads, we may also use Azure Data Studio to assist with database migrations.
- The tools above are used to perform the actual migrations, in a controlled manner.
- We'll then work with your teams for functional testing to ensure that each workload has been migrated in accordance with the run-book.

## **CLIENT DEPENDENCIES**

We'll need some information from you, to make sure that we're able to carry out the engagement and provide the expected output:

- Attendance at the Planning Workshop.
- Timely approval of the Runbooks and any associated documentation in order to proceed without delay.
- Administrative access to your Microsoft Azure tenant. If you don't have one yet, we'll help you to get that set up.
- Support to navigate any change management processes that the migrations may need to work within.
